Moog Inc. (NYSE: MOG.A and MOG.B) announced that it has acquired the remaining 60% ownership of the wind energy business of LTI REEnergy GmbH in Unna, Germany and Shanghai, China. The consideration was EUR12 million in cash paid and the issuance of a EUR9.5 million note payable in February 2010.

After taking a 40 percent ownership stake in privately held LTI REEnergy GmbH last June, Moog Inc. has acquired the remaining 60 percent of the company. As a result of the transaction, Moog is acquiring two manufacturing and testing facilities, one in Unna, Germany, and the other in Shanghai, China.
