Although containing nearly 90% of the inhabitants of Saint Pierre and Miquelon, the commune of Saint-Pierre is considerably smaller in terms of area than the commune of Miquelon-Langlade, which lies to its northwest on Miquelon Island.

What was the purpose of Saint Pierre & Miquelon?

Saint-Pierre was an outpost used to transport alcohol from Canada to the United States during Prohibition. [4] Until 1945, there existed a third commune in Saint Pierre and Miquelon: L'Île-aux-Marins. The commune of L'Île-aux-Marins was annexed by the commune of Saint-Pierre in 1945.

How did Saint-Pierre and Miquelon become a territory?

After the 1958 French constitutional referendum, the territory of Saint-Pierre and Miquelon was asked to choose one of three options: becoming fully integrated with France, becoming a self-governing state within the French Community, or preserving the status of an overseas territory; it decided to remain a territory.
