

Should solar photovoltaic firms oppose trade sanctions?

Finally, we expect downstream firms that install solar photovoltaic systems, and that develop projects, to oppose policies that increase the costs of their inputs. Trade sanctions imposed on Chinese module manufacturers, for example, should hurt firms using these materials as inputs.

What is the global PV trade based on?

The data on global PV trade used in this paper comes from the BACI-CEPII 2 Database, covering 251 global economies from 1996 to 2019. According to the division of the PV industry, the upstream is composed of crystalline silicon raw materials and the preparation of silicon rods and silicon wafers.

Should China impose trade barriers on solar PV modules?

A statement from the organization noted its opposition to the imposition of trade barriers on module imports from China, noting that "SEMI continues to strongly advocate for policies that promote the deployment of solar PV as an answer to energy challenges. The findings of these cases may lead to significant price increases on solar PV systems.

Should China optimize its TBT policies for photovoltaic products?

China should optimize its TBT (Technical Barriers to Trade) policies for photovoltaic products by enhancing product quality and technical standards to ensure compliance with international standards such as those established by the International Electrotechnical Commission (IEC) and the International Organization for Standardization (ISO).

Why is international trade important for PV cells?

Through the interaction of spatial patterns of PV cells international trade flow, the associations among regions have been strengthened and the development opportunities of PV industry have been expanded. This will also intensify the level of competition.

Does trade protectionism affect China's solar PV exports?

Zhu et al. (2021) examined the impact of both internal and external forces on China's solar PV export during 2007-2016, and found that trade protectionism and some non-tariff barriers inhibit China's PV exports.
