How to install solar panels?

The basic system is to start with the installation of a rack or platform. If the panels are roof-mounted, a roof racking system is first installed. A ground platform is needed if the panels are ground-mounted, and installing the solar panels is not difficult. What is more difficult is wiring them.

Can solar panels be installed on a flat roof?

You can install solar panels on a flat roof, but it's not usually a good idea for domestic properties.

Where should solar panels be placed?

The most important piece of your solar panel system will be the solar array itself. You want your solar panels placed in a sunny spoton your property. The panels should face south for optimal energy production, but they can also face east or west and still produce a good amount of electricity, so long as the area is clear of shade.
