How much can you earn from solar panels?

Depending on how much you're able to export, those rates could make a substantial difference to how much you could earn. A household with a fairly typical solar panel set-up* could earn £69 more a year (£84 vs £15) with the highest-paying tariff rather than the lowest-paying. How much does a photovoltaic system cost in the UK?

o A household in the UK installs a 5kW photovoltaic system costing £8,000 (average cost), which would generate approximately 4,320 kWh of electricity annually. o The annual SEG income in the UK would be £324 per annum.

How can I get paid for solar panels?

Additionally, Good Energy launched a new scheme in October 2024, which helps you get paid for the certificates (REGOs) produced when your solar panels generate electricity. Energy suppliers buy them to show that the electricity they sell is renewable.

How much does a 3.5 kWp solar panel system cost?

A 3.5 kWp solar panel system would typically require around 10 solar panels (at 350 W each) and cost between £5,000 and £10,000. *kWp stands for 'kilowatt peak'. This is the amount of power that a solar panel or array will produce per hour in prime conditions.

Does it pay for solar panels?

The FIT scheme still pays many solar panel owners for the electricity they generate at home, but it is closed to new applicants. All large energy suppliers - with more than 150,000 domestic electricity customers - must participate in the SEG. Smaller suppliers can choose to offer solar export tariffs too.
