#### Who is INEOS?

## Will Ineos invest in shale gas in the UK?

In November 2014, Ineos announced plans to invest up to £640m in shale gas exploration in the UK. The company planned to use the gas as a raw material for its chemicals plants, including Grangemouth near Falkirk. Ineos CEO, Jim Ratcliffe, has criticized restrictions on fracking in the UK.

## Where is INEOS headquartered?

Ineos' headquarters in London, England. Ineos Group Limited is a British multinational conglomerate headquartered and registered in London.

## How many companies did Ineos buy?

The first phase spanned over ten years, with Ineos acquiring 22 companies between 1998 and 2008. The two most notable of these were Innovene, the olefins and derivatives and refining subsidiary of BP, in October 2005 for \$9 billion, and ICI's commodity chemicals business in 2001.

## What are some examples of Ineos energy?

Good examples of this are Project Greensand, our pioneering Carbon Storage project in the Danish North Sea and our investment in HydrogenOne Capital. "At INEOS Energy we are looking to provide the tools for people to be able to decarbonise their energy consumption."
