Did new East solar violate US tariff laws?

New East Solar, the official said, "essentially said, 'Please leave, we will not cooperate." Commerce added it to the list because it could not independently verify the company was not violating US tariff laws. The department also determined that three other solar manufacturers - Hanwha, Jinko and Boviet - were in compliance with US laws.
