Why does Macao have a trade surplus?

#### Why is the EU working with Macao?

The EU is working with the Macao Government to diversify its economy, improve the sustainability of its economic development and promote bilateral trade and investment. The EU is Macao's second largest supplier after China, providing one-fourth of its imports in goods in 2018.

#### What does the Macao SAR office do?

Its role is to assist the Chief Executive of the Macao SAR in the fields of economic and trade relations and cooperation between the Macao SAR and the EU and related institutions. The Office is directly affiliated to the Chief Executive of the Macao SAR and enjoys administrative autonomy.

#### Where is Macao SAR located?

The Macao SAR consists of the Macau Peninsula, Taipa Island and Coloane Island. Located on the southeast coast of China, it is located on the west bank of the Pearl River Delta, about 60 km away from Hong Kong. According to the Cartography and Cadastre Bureau of the Macao SAR, the total land area of Macao in 2016 was 30.5 square kilometres.

EU-Macao bilateral trade is almost exclusively (more than 95%) composed of exports to the EU, with around 33% of Macao's imports originating in the EU. Based on Eurostat data, EU bilateral trade in goods with Macao in the first 11 months of 2022 amounted to EUR 1 147 million (less than a 1% increase over 2021).

The report shows a growing focus on national security that bears the risk of undermining fundamental freedoms in Macao and eroding the "one country, two systems" principle and Macao"s high degree of autonomy.
