

What does Seda do for Malaysia?

SEDA sets the solar feed-in tariff for Malaysia and was tasked by the Malaysian Government to develop a roadmap to decarbonise the country's energy systems. As part of this, SEDA has looked to take advantage of the country's relatively large capacity for solar generation.

What is solar for Rakyat incentive scheme (Solaris)?

According to the media statement released by the YAB Deputy Prime Minister and Minister of Energy Transition and Water Transformation (PETRA) on 27 March 2024, the government has introduced a specific incentive program to encourage the installation of solar PV systems for domestic consumers known as the Solar for Rakyat Incentive Scheme (SolarIS).

What is Seda's P2P sandbox?

SEDA ran a trial of P2P technology between October 2019 and June 2020. With help from regulating authorities and power utilities, the authority built an energy trading sandbox for prosumers and consumers. To allow this, SEDA had to build a data aggregator to format meter data from utility TNB and feed it into the trial's online P2P platform.

Will P2P trading encourage photovoltaic solar generation in Malaysia?

It currently operates across ten countries. Power Ledger head of business development Vinod Tiwari said P2P trading would encourage photovoltaic solar generation, as 95% of Malaysia's power comes from fossil fuels. Company co-founder and executive chairman Jemma Green spoke at the IRENA seminar, giving results from the Malaysian trial.

How much does a solar project cost in Pohnpei?
