Reliance New Energy Solar Limited(RNESL), a subsidiary of India-based holding company Reliance Industries Limited (RIL), has acquired a complete stake in solar cell and panel manufacturer REC Solar Holdings (REC Group). The company acquired REC Group from China National Bluestar for \$771m.

Who owns reliance new energy solar?

According to solar PV research company PVinsights, worldwide shipments of solar modules in 2011 was around 25 GW, and the shipment year-over-year growth was around 40%. The top five solar module producers in 2011 were: Suntech, First Solar, Yingli, Trina, and Canadian.

Is Reliance Industries buying REC Group?

Reliance Industries is close to acquiring Europe's largest solar panel manufacturer, REC Group, for \$1-1.2 billionfrom China National Chemical Corp (ChemChina).

The company operates two manufacturing facilities in Norwaythat produce solar-grade polysilicon, while its Singapore facility manufactures PV cells and modules.
