Paris, June 26, 2024 - TotalEnergies has signed an agreement to acquire a 60% interest and operatorship in Block STP02, offshore Sao Tome and Principe, from the Agencia Nacional do Petróleo de S. Tomé e Príncipe (ANP-STP). The remaining interest will be held by the existing license holders, Sonangol (30%) and ANP-STP (10%).
