Could Australia help Tonga get through on its debt?

The alternative scenario, currently unfolding, sees Australia enable Tonga to scrape through on its debt repayments with its strained relationship with China kept in open air. Nonetheless, Tonga, China, and Australia are all walking a debt tight rope. Tonga is highly exposed to frequent climatic disasters.

Where does Tonga's debt come from?

Most of Tonga's external debt originates from a 2008 loan provided by China's EXIM Bankto help finance the rebuilding of the Nuku'alofa central business district following the 2006 pro-democracy riots. The loan was controversial from the outset as the debt pushed Tonga's risk indicators beyond sustainable benchmarks.
